**NOTICE FOR AUCTION SALE OF CRANE**

Sealed Tender in plain paper super scribed with the words" **OFFER FOR AUCTION SALE OF VEHICLE** "are invited by the undersigned for auction of **one Crane bearing Regd. NO.OR05G-8348**. The offset price of the vehicle has been fixed by the Joint inspection Committee comprising DCT(C/Z), Cuttack & IMV , Cuttack at Rs.1,20,000/- (Rupees One Lakh Twenty thousand only ).

The intending tenderers may inspect the vehicle parked in the premises of Cuttack Sadar Police Station, Bhanpur , Cuttack during working hours before the submission of tender. The tenderer is required to deposit earnest money of Rs.1000/- only in shape of Demand Draft in favour of RTO, Cuttack and submit the same along with the tender paper which will be returned to the unsuccessful tenderers after finalization of the Tenders. The EMD of successful Tenderer would be adjusted against the Tender amount.

The sealed tender will be received by the office of the undersigned in a box installed in the office on or before **25/05/2018 by 2.00 P.M.** and shall be opened on the same day at **4.00P.M.** in the office chamber of RTO in presence of the tenderers or their authorized representatives. The successful tenderer shall have to deposit 100% of the tendered amount immediately after the sale is confirmed failing which the tender will be cancelled and the Earnest money so deposited will be forfeited.

The successful tenderer shall remove the vehicle from the premises of Cuttack Sadar Police Station within 7 days from the date of depositing the full bid amount , failing which the office will not be responsible for any damage, pilferage and no claim in this regard will be entertained by the office. On failure to remove the vehicle within the above stipulated period, the ground rent @1% of the tendered amount shall be charged for each day or part thereof till removal of the vehicle from the above place. If the ground rent so charged exceeds the sale price deposited, the tenderer shall cease to have any right on the vehicle and the amount deposited by the him shall be adjusted towards ground rent.
