At the outset the Chairman, S.T.A. welcomed all the members of the S.T.A to the 286<sup>th</sup> S.T.A meeting.

#### ITEM NO - 1

The proceeding of the 285<sup>th</sup> meeting of State Transport Authority held on 08.02.2018 circulated among all the members vide this office memo No.2121 dtd.16.02.2018 is confirmed as no objections received.

Action taken by the Chairman, STA, Secretary, S.T.A. & Under Secretary, STA in pursuant to delegation made in 193<sup>rd</sup> meeting held on 12.11.1992 and subsequent meeting for the period from 08.02.2018 to 30.05.2018 are approved.

#### POLICY DECISION

#### TRANSFER OF PERMANENT STAGE CARRIAGE PERMIT

Policy decision for transfer of stage carriage permit was taken in the 228<sup>th</sup> STA meeting held on 28.02.2005, 231<sup>st</sup> meeting held on 24.12.2005 and 279<sup>th</sup> meeting held on 17.06.2015 to prevent trafficking of permit and to protect interest of travelling public.

In 279<sup>th</sup> STA meeting following decision was taken.

In cases where the permit holder is suffering from terminal disease that cannot be cured or adequately treated and that is reasonably expected to result in the death of the patient within a short period of time. The disease such as cancer or advanced heart disease or being physically handicapped above 80%



supported by certificate issued by the medical board and unable to operate the bus / buses on give route / routes.

After due deliberation, the members of STA reserved that, the figures "80%" be substituted by figures "60%".

## CONSIDERATION OF APPLICATIONS FOR STAGE CARRIAGE PERMITS ON INTER-STATE ROUTE

## ITEM NO.3.1:- SAMBALPUR TO BOKARO

Reciprocal Transport Agreement executed between Odisha and Jharkhand the route **Sambalpur to Bokaro** was notified U/s 88 (6) of MV Act, 1988 published in Odisha Gazette vide Notification No.2007/374, dated 28.02.2007, Annexure-A (SI No.10), STA, Odisha has to grant 01 permit with 01 trips covering Odisha portion distance 220 kms and Jharkhand portion distance is 336 Kms as Express Service.

Pursuant to the advertisement published in daily Odia News Paper "The Samaj" and "Sambad" and English News Paper "Times of India" on dated 09.05.2018 CMD, OSRTC, Bhubaneswar has applied for grant of Permanent Permit in respect of their vehicle OR19H-0745 and OR15R-2125 on the above mentioned notified route. The vacancy was due to non-receipt of application on the above route.

Whereas there is, provision of 01 permit and 01 trip in the Reciprocal Transport Agreement. The member felt that there should be two permits and two trips for the convenient to the travelling public to operation of alter service on the distance in portal 556 kms.

After deliberations, it was decided to grant 02 permanent stage carriage permits in favour of CMD, OSRTC, Bhubaneswar, in respect of their vehicle OR19H-0745 and OR15R-2125 in the interstate route Sambalpur to Bokaro to perform single trip daily for a period of five years, as Express Service as alter service, subject to verification of original documents submitted by him and requested to Secy, STA, Jharkhand to add one permanent permit in the next reciprocal transport agreement. The permit is valid subject to grant of countersignature by STA, Jharkhand. The permit holder will get the permit countersigned within 60 days failing which the permit is liable to be cancelled. The grantee shall lift the permit within a period of ten days from the date of communication of grant order failing which such grant of permit is liable to be cancelled.



The grantee can however replace the present vehicle by another vehicle which is either equal to or higher in terms of model and facilities provided in the present vehicle. These conditions shall form a part of the Permit conditions. Before issue of permit Tax payment position, Audit and VCR clearance should be obtained and it should be ensured that the vehicle was not off-road on the date of application and on the date of consideration.

#### ITEM NO.3.2- CHAIBASA TO GORUMAHISANI

Reciprocal Transport Agreement executed between Odisha and Jharkhand the route **Chaibasa to Gorumahisani** was notified U/s 88 (6) of MV Act, 1988 published in Odisha Gazette vide Notification No.2007/374, dated 28.02.2007, Annexure-A (SI No.21) STA, Odisha has to grant 01 permit with 02 trips covering Odisha portion distance 60 kms and Jharkhand portion distance is 112 kms as Ordinary Service.

Pursuant to the advertisement published in daily Odia Newspaper "Samaj", "Sambad" and "Time of India" on dated 09.05.2018 only one Girish Chandra Bhoi, owner of OD11J-1985 has applied for grant of Permanent Permit on the above mentioned notified route. The vacancy arose due to non-receipt of application in the said route.

The applicant has submitted a solvency of Rs.50,000/- after that tax clearance and other duty. After deliberations, it was decided to grant permanent stage carriage permit in favour of Sri Girish Chandra Bhoi, owner of vehicle No.OD11J-1985 in the interstate route Chaibasa to Gorumahisani to perform two trips daily for a period of five years, as Ordinary Service, subject to verification of original documents submitted by him. No change of timing shall be allowed. The grantee shall lift the permit within a period of ten days from the date of communication of grant order failing which such grant of permit is liable to be cancelled. The grantee can however replace the present vehicle by another vehicle which is either equal to or higher in terms of model and facilities provided in the present vehicle. These conditions shall form a part of the Permit conditions. Before issue of permit Tax payment position, Audit and VCR clearance should be obtained and it should be ensured that the vehicle was not off road on the date of application and on the date of consideration.

Reciprocal Transport Agreement executed between Odisha and Jharkhand the route Deoghar to Rourkela was notified U/s 88 (6) of MV Act,1988 published in Odisha Gazette vide Notification No.2007/374, dated 28.02.2007, Annexure-A (SI No.25) STA, Odisha has to grant 02 nos. of permit with 02 trips covering Odisha portion distance 40 kms and Jharkhand portion distance is 524 kms as Express Service.

Pursuant to the advertisement published in daily Odia Newspaper "Samaj", "Sambad" and "Times of India" on dated 09.05.2018 only one MD, OSRTC, Bhubaneswar, owner of OD09B-5135 has applied for grant of Permanent Permit on the above mentioned notified route. Accordingly the application filed Pramod Kumar Ray, Owner of vehicle AP16TB-6800 is rejected.

4. Applicant Sri Pramod Ku. Ray has applied for grant of All India Tourist Permit under section 88(9) of MV Act.1988 in respect of vehicle No.AP16TB-6600 which is of 2010 Model and registered on 08.04.2010.

Rule 82(1) (a) of CMV Rules provides that a tourist permit shall be deemed to be invalid from the date on which the Motor Vehicle completes 8 years from the date of initial registration.

In the present case the vehicle No.AP16TB-6600 was registered on 08.04.2010 and would complete 08 years on 07.04.2018. That for no permit will be granted to aforesaid vehicle which is more than 08 years old.

After due deliberation, it was decided not to grant All India Tourist Permit to vehicle No.AP16TB-6600.

Accordingly the application filed Pramod Kumar Ray, Owner of vehicle AP16TB-6600 is rejected.

#### New fare structure for Hi-Tech Buses

Due to advent of technology, new buses of Multinational Company like Volvo, Scania etc with high passenger comfort have come to India. But due to their high cost, the fare structures need to be different as in other States for operators to buy them and operate in Odisha.

It is decided that Govt. of Odisha, Commerce and Transport (T) Deptt. will be requested to formulate a new fare structure for these buses.
