E-Checkpost portal has been implemented in the State under 5T initiative of Government of Odisha to improve ease of getting permit, make payment of tax and fee in online mode in respect of other State transport and non-transport vehicles.

Earlier e-checkpost portal was enabled only to provide the service relating to goods vehicles and contract carriage vehicles vide this Office Order No.1238 dated 27.01.2020.

Now the following categories of other State vehicles owner can pay the tax, fees and obtain the temporary permit / obtain the tax receipt online before entering into Odisha by visiting the e-checkpost portal (https://parivahan.gov.in)from any place of their convenience by availing the online facility:

The vehicle owners can download receipts for payment of tax, fee and permit copy (wherever applicable) and get the printout at their convenience before entering into Odisha for hassle free movement of vehicles in the State of Odisha.
