
**ORDER**

Government in Commerce & Transport (Transport) Department vide notification No.4662/T dated 24.05.2021 has exempted M.V.tax/addl. Tax in respect of Stage Carriages, Contract Carriages and Educational Institution Buses for April & May, 2021.

As per section 11 of OMVT Act, 1975, where excess tax has been paid for any period, same can be adjusted towards tax due for any subsequent period.

It is hereby ordered that in cases where owner of Stage Carriage and Contract Carriage has paid M.V.tax/addl. Tax for April & May, 2021, such tax will be adjusted for subsequent period by the concerned RTO. In cases where a vehicle is under off road and made on road, tax paid for April and May, 2021 may be adjusted for the month in which the vehicle will be made on road. For this purpose, the RTO will check off road / on road status of stage carriage / contract carriage in every month and take steps for adjustment of tax.

Since there is no provision for payment of monthly tax in respect of Educational Institution Bus, in cases where Educational Institutions have paid annual tax for the year 2021-2022 in respect of buses owned by them, tax paid for April-May, 2021 proportionately will be adjusted for subsequent period by the concerned RTO for two months for the year 2022-2023.
