The applicants have been noticed to appear before STA on 17.08.2021 vide this office letter No.7985/TC dated 03.08.2021 through Video Conference for hearing. The matter is placed before STA for decision.

INTER-STATE ROUTES (CASE MATTER)

ITEM No.26: Intimation regarding Countersignature by the STA, Chhatisgarh in respect of vehicle no.OD05AD-5484 to operate on the Inter-State route Bhadrak to Raipur via. Deogarh, Bargarh and back.

Permanent Permit No.03-G-2020 has been issued in favor of Sri Satyanarayan Das in respect of vehicle no.OD05AD-5484 to operate on the Inter-State route Bhadrak to Raipur via. Deogarh, Bargarh and back to perform one single trip daily valid till 03.02.2025 with a condition to countersign the said permit within a period of Sixty (60) days from STA, Chhatisgarh, failing which the permit is liable to be cancelled. Accordingly, Secretary, STA, Chhatisgarh, Raipur has been intimated vide this office lt. no.1639/TC, dt.03.02.2020 to countersign the said permit.

Sri Das had filed an application on dt.24.02.2020 before this authority for modification of timings in respect of the above mentioned vehicle which was processed and it was ordered that the applicant will furnish copy of countersignature granted by Chhatisgarh. The owner was intimated vide this office letter No.4096/TC dt.21.03.2020 to furnish the copy of countersignature within a period of 10 days.

Permit holder has filed petition on 07.12.2020 not to take any coercive action as he has taken all possible steps to get the permit countersigned by STA, Chhatisgarh within the stipulated period. It was ordered by Chairman to place the matter in STA meeting.

The applicant has been noticed to appear before STA on 17.08.2021 vide this office letter No.8425/TC dated 11.08.2021 through Video Conference for hearing. The matter is placed before STA for decision.

ITEM No.27: Grant of Permanent Permit in favour of Sri Sourabh Ranjan Pradhan in respect of vehicle no.OD05AE-0015 to operate on the Inter-State route Berhampur to Tata renamed as Berhampur to Ranchi and back.

Sri Sourabh Ranjan Pradhan, owner of vehicle no.OD05AE-0015 has prayed before this authority to issue Permanent Permit in respect of his above mentioned vehicle to operate on the Inter-State route Berhampur to Tata renamed as Berhampur to Ranchi and back.

The matter was placed in the 293rd STA meeting held on 14.12.2020 and his application was rejected. It was found that declaration in Annexure-A and B were not taken into consideration by STA inadvertently.

As per order passed by the Chairman, STA permanent permit has been issued to Sri Sourabh Ranjan Pradhan, owner of vehicle no.OD05AE-0015 in the route Berhampur to Tata renamed as Berhampur to Ranchi and back.

This is placed before STA for approval.

ITEM No.28: Renewal of permanent permit in respect of vehicle no.OR11E-1545 to operate on the Inter-state route Puri to Kolkata via. Laxmannath and back.

Permanent Permit no.11-R-2015 was issued in favor of Sri Prakash Chandra Sahoo in respect of vehicle no.OR11E-1545 to operate on the Inter-state route Puri to Kolkata via. Laxmannath and back valid till 16.04.2020.

The permit holder has applied for grant of renewal of permanent permit on dt.13.01.2020 which was processed and it was ordered to the owner to furnish a higher model vehicle vide this office letter no.3075/TC, dt.29.02.2020. Further on verification from VAHAN-4 database, it is found that the said vehicle was kept off-road for a period from 01.07.2018 to 31.12.2019 and released from off-road on dt.05.12.2019.

As per decision taken in 264th STA meeting held on 31.01.2012, it has been resolved that "It was resolved that, if a vehicle is continuously declared off-road for more than six months, it will be presumed that either the vehicle is so badly damaged that it cannot be repaired or the operator does not have adequate financial resources to get the vehicle repaired. In such a cases, if the vehicle is covered under permit and the vehicle covered in it is declared off-road for more than three months and less than six months, the route will be notified. If the vehicle is operating under Permanent Permit and declared off road for more than six months it will be deemed

that his performance as a stage carriage operator is not satisfactory. In such event, the P.P. so granted is to be suspended / cancelled following procedure laid down under section 86 of M.V. Act, 1988.”

The permit holder has been noticed vide this office letter No.8428/TC dated 11.08.2021 to appear before STA for hearing through video conference regarding consideration of his application for renewal of permanent permit.

ITEM No.29: Renewal of permanent permit in respect of vehicle no.OR11G-7646 to operate on the Inter-state route Phulbani to Tata via. Bhubaneswar, Balasore, Baripada, Jamsola and back.

Permanent Permit vide permit no.18-G-2015 has been issued in favor of Sri Debendra Barik in respect of vehicle no.OR11G-7646 to operate on the Inter-state route Phulbani to Tata via. Bhubaneswar, Balasore, Baripada, Jamsola and back valid till 27.08.2020.

In the meantime, he had applied for grant of renewal of permanent permit on dt.01.07.2020 by depositing the requisite Application fees. On verification from VAHAN-4 database, it is seen that the said vehicle was kept off-road for a period from 01.07.2018 to 31.12.2020. Thus the vehicle was kept off-road for a period of more than two years.

As per decision taken in 264th STA meeting held on 31.01.2012, it has been resolved that “It was resolved that, if a vehicle is continuously declared off-road for more than six months, it will be presumed that either the vehicle is so badly damaged that it cannot be repaired or the operator does not have adequate financial resources to get the vehicle repaired. In such a cases, if the vehicle is covered under permit and the vehicle covered in it is declared off-road for more than three months and less than six months, the route will be notified. If the vehicle is operating under Permanent Permit and declared off road for more than six months it will be deemed that his performance as a stage carriage operator is not satisfactory. In such event, the P.P. so granted is to be suspended / cancelled following procedure laid down under section 86 of M.V. Act, 1988.”

Accordingly, the owner was directed to file show cause within a period of fifteen days as to why the permanent permit no.18-G-2015 shall not be cancelled for the above lapses vide this office lt. no.10868/TC, dt.09.12.2020. To this the learned Advocate on behalf of Sri Barik, owner of vehicle no.OR11G-7646 had filed a reply to

the show cause which was processed and has been ordered to place the matter in the next STA meeting for decision.

The permit holder has been noticed vide this office letter No.8411/TC dated 11.08.2021 to appear before STA for hearing through video conference regarding consideration of his application for renewal of permanent permit.

ITEM No.30: Intimation regarding registration number of all stage carriages owned by OSRTC and CRUT in Annexure-A, B and C.

The STA in its 291st meeting held on dt.19.02.2020 and 293rd meeting held on dt.14.12.2020, decided that at the time of filing application for grant of permanent stage carriage permit, the owner will have to submit self-declaration in Annexure-A disclosing total number of stage carriages owned by applicant, tax payment position and pendency of VCR / e-challan dues etc. The applicant will have to submit self-declaration in Annexure-B on the date of hearing / consideration of applications. These above stipulations will be applicable for single and multiple applications.

Similarly, at the time of filing application for renewal of stage carriage permit, the applicant will submit self-declaration in Annexure-C.

Since OSRTC and CRUT operate large number of stage carriages, it may not be practicable on their part to furnish registration number of all stage carriages owned by them. Submission of Annexure-A, B and C will not be insisted at the time of filing application for grant / renewal of permanent stage carriage permit.

Hence, the matter is placed in STA meeting for decision.

INTER-REGION ROUTES (CASE MATTER)

ITEM No.31: Renewal of permanent permit in respect of vehicle no.OR11L-3792 to operate on the route Gorumahisani to Bhubaneswar via. Jashipur and back.

Permanent Permit vide permit no.PP99/160024/G has been issued in favor of Sri Ranjan Kumar Mahala in respect of vehicle no.OR11L-3792 to operate on the route Gorumahisani to Bhubaneswar via. Jashipur and back valid till 03.02.2021.

In the meantime, he had applied for grant of renewal of permanent permit on dt.20.01.2021 through online in OPMS by depositing the requisite Application fees. On verification from VAHAN-4 database, it is seen that the said vehicle was kept off-road for a period from 01.12.2019 to 31.12.2020 (one year).

As per proceedings passed in 291st STA meeting held on dt.19.02.2020, it has been resolved that “where the vehicle for which permanent stage carriage permit was issued in a route / routes had been declared off road for a period of one year during currency of permit in different spells, renewal of such permit shall not be considered. Besides steps will also be taken for cancellation of permit before its expiry under Section 86 of M.V. Act, 1988. The permit holder will furnish / upload self-declaration in Annexure-C at the time of making application for renewal of permit.”

Accordingly, the owner was directed to file show cause within a period of fifteen days as to why the permanent permit no.PP99/160024/G shall not be cancelled for the above lapses vide this office lt. no.1508/TC, dt.03.02.2021. To this he had filed a reply to the show cause which was processed and has been ordered to place the matter in the next STA meeting for discussion and decision.

The permit holder has been noticed vide this office letter No.8424/TC dated 11.08.2021 to appear before STA for hearing through video conference regarding consideration of his application for renewal of permanent permit.

ITEM No.32: Renewal of permanent permit in respect of vehicle no.OR02BD-2199 to operate on the route Cuttack to Baliguda via. Nayagarh, G. Udayagiri and back.

Permanent Permit vide Permit No.PP99/140261/G was issued in favor of Sri Gangadhar Sundaray in respect of vehicle no.OR02BD-2199 to operate on the route Cuttack to Baliguda via. Nayagarh, G. Udayagiri and back which was valid till 19.04.2019.

Meanwhile, he had applied for grant of renewal of permanent permit on dt.14.11.2019 through online in OPMS by depositing the requisite Application fees.

As per Sec 81 (ii) of M.V Act, 1988, “application for grant of renewal of Permanent Permit must be made before fifteen days of expiry of existing Permanent Permit.” But in this case, the owner has filed the application for grant of renewal of Permanent Permit after lapse of seven months of expiry of permanent permit stating in his application that the vehicle OR02BD-2199 was declared off-road for the period from 01.01.2019 to 31.10.2019.

To this, the said application was processed through online and was ordered for notifying the route for inviting applications from the interested operators.

Being aggrieved, the learned Advocate on behalf of Sri Gangadhar Sundaray had filed a M.V Appeal No.19 of 2019, wherein the Hon'ble STAT, Odisha, Cuttack had ordered that, "the matter is remitted back to the STA, Odisha, Cuttack for fresh consideration of the application of the appellant for renewal of his Permanent Permit within one month from the date of receipt of the judgment by extending the opportunity of hearing to the appellant as per the mandate of Second Proviso of Sub Sec.4 of Sec.81 of the M.V Act."

The permit holder has been noticed vide this office letter No.8421/TC dated 11.08.2021 to appear before STA for hearing through video conference regarding consideration of his application for renewal of permanent permit.

ITEM No.33: Cancellation of Permanent Permit no.SC/SIRP99/01781/2019 issued to vehicle no.OR07T-1441 in the inter-region route Hinjilicut to Cuttack (Badambadi) via. Balugaon, Chandapur and back.

Permanent Permit has been issued in favor of Zakira Begum in respect of vehicle no.OR07T-1441 to operate on the route Hinjilicut to Cuttack (Badambadi) via. Balugaon, Chandapur and back valid till 06.08.2024.

In the meantime, it was brought to the notice of this authority that the said vehicle met with a severe accident on dt.10.02.2020 at Mendarajpur in Berhampur which took several lives in the said mishap.

The owner was directed vide this office Lt. no.2359/TC, dt.18.02.2020 to file a show cause within fifteen days as to why the permanent permit shall not be cancelled for violation of permit condition.

Meanwhile, the Deputy Secretary to Government vide his Lt. no.2160/T, dt.25.02.2020 had requested this authority for cancellation of the permanent permit so issued in respect of vehicle no.OR07T-1441 as the vehicle was plying without special / contract carriage permit from N.H-16 towards Chikarda on Tulu Road.

The permit holder has been noticed vide this office letter No.8423/TC dated 11.08.2021 to appear before STA for hearing through video conference regarding cancellation of permanent permit. The matter is placed before STA for decision.

ITEM No.34: Consideration of application for grant of Permanent Permit in respect of vehicle no.OD02AS-0779 in the inter-region route Khurdha to Bholagadia via. Cuttack, Bhadrak, Soro and back.

Temporary Permit for a period of 119days was granted in favor of Smt. Pranati Nalini Samantara in respect of vehicle no.OD02AS-0779 to operate on the route Khurdha to Bholagadia via. Cuttack, Bhadrak, Soro and back valid till 01.06.2018. Thereafter she had applied for grant of Permanent Permit on dt.02.05.2018 through online in OPMS. The said application was ordered to be kept pending as the said T.P was issued mistakably on the rationalized route Bhubaneswar – Baripada.

Being aggrieved to this, the learned Advocate on behalf of Smt. Pranati Nalini Samantara had furnished a Memo in W.P (C) No.20815/2018 wherein the Hon'ble High Court of Orissa passed order "directing the opposite party No.1 to take a decision on the representation under Annexure-5 filed by the petitioner within a period of three weeks." The said order was processed and orders have been passed by Chairman, STA as "the application filed by Smt. Samantara for grant of Permanent Permit and prayer so made in the representation under Annexure-5 are rejected."

In the meantime, she filed a representation before this authority for grant of Permanent Permit in respect of vehicle no.OD02AS-0779 to operate on the route Khurdha to Bholagadia via. Cuttack, Bhadrak, Soro and back along with a copy of order passed by the Hon'ble Standing Counsel (T) in M.V Appeal No.8 of 2019 wherein " the appeal is dismissed against the respondents without cost." The same has also been processed and ordered to keep up to the finalization of timings on the Bhubaneswar – Baripada route.

The matter was placed in the 292nd Virtual meeting of STA held on dt.15.09.2020 through Video Conferencing wherein, orders as follows was passed, "Being aggrieved the applicant had filed W.P. (C) No.7991/2020 before Hon'ble High Court which was disposed of on 04.03.2020. The Hon'ble High Court has directed that the representation of the petitioner be worked out keeping in view the development made. As directed by Hon'ble High Court, representation of the petitioner has been duly considered by STA. The timing of stage carriages operating in the route Bhubaneswar to Baripada via Cuttack / Balasore / Bhadrak has been rationalized and final rationalized timing implemented. The route and timing applied for by the applicant covers major portion of rationalized route. The STA after due deliberation, resolved to reject the application for temporary permit filed by the

applicant as no vacant timing slots available for issuance of permit to her in the applied route.”

The applicant has been noticed vide this office letter No.8420/TC dated 11.08.2021 to appear before STA for hearing through video conference.

The matter is placed before STA for decision.

ITEM No.35: Consideration of application for Modification of Timings in respect of vehicle no.OD02AA-2550 operating in the inter-region route from Cuttack to Berhampur and back.

Sri Debasish Behera, owner of vehicle No.OD02AA-2550 operating on the route Cuttack to Berhampur on the strength of permanent permit issued by this authority has applied for change of up-trip dept time at Cuttack 05.00 AM instead of 07.45 AM to Berhampur. Secretary STA had allowed to dept. from Bhubaneswar at 07.55 instead of 09.15 in MV Misc Case No. 72/20, dt. 28.12.2020. Thereafter, the owner has filed an application before the Chairman, STA and requesting to allow the vacant time to dept. Bhubaneswar within the time 06.20 AM to 06.45 AM towards Berhampur.

As per settled principle of law, any order passed by Secretary, STA is appealable under Section 89 of M.V. Act, 1988.

The applicant has been noticed vide this office letter No.8419/TC dated 11.08.2021 to appear before STA for hearing through video conference.

The matter is placed before STA for decision.

ITEM No.36: Cancellation of permanent permit No.SC/SIRP99/01569/2020 issued in respect of vehicle No.OD04N-3985 operating in the inter-region route from Bhubaneswar to Gereda via.Buguda, Balipadar and back.

Permanent Permit No.SC/SIRP99/01569/2020 issued in favour of Sri Asutosh Sarangi in respect of his vehicle No.OD04N-3985 to operate in the inter-region route from Bhubaneswar to Gereda via.Buguda, Balipadar and back valid till 31.10.2025.

In the meantime the permit holder applied for acceptance of Surrender PP through OPMS on dtd. 10.02.2021. The said application was rejected by Chairman, STA as the permit holder had not completed one year service on the existing route and timing.

Thereafter, ownership of vehicle has been transferred from the name of Sri Asutosh Sarangi to the name of Sri Naranjan Nayak on 09.03.2021 by RTO, Chandikholoe so far as VAHAN-4 database is concerned.

It is pertinent to mention here that the permit holder has not challenged the order passed by the Chairman, STA before Hon'ble STAT which has reached its finality. At present the permit should be cancelled.

The applicant Sri Naranjan Nayak has been noticed vide this office letter No.8418/TC dated 11.08.2021 to appear before STA for hearing through video conference.

The matter is placed before STA for decision.

ITEM No.37: Consideration of application for grant of Permanent Permit in respect of vehicle no. OR08C-0915 in the inter-region route Dharmagarh to Kantabanji and back.

Permanent Permit No.PP99/150248/G was issued in favour of Sri Nilakantha Das in respect of his vehicle No. OR08C-0915 to operate in the Inter Region route Dharmagarh to Kantabanji and back valid till 07.05.2021.

The permit holder has filled application on 18.02.2021 for grant of renewal of PP for further period of 5 years through online in OPMS.

The permit holder has been kept off-road for the period from 01.04.2018 to 31.03.2021 i.e. for 2 years 10 months. STA in 264th meeting subsequently 291st STA meeting, resolved that "where the vehicle for which permanent stage carriage permit was issued in a route / route has been declared off road for a period of one year during currency of permit in different spells, renewal of such permit shall not be considered. Besides, steps will also be taken for cancellation of permit before its expiry under section 86 of M.V. Act, 1988. The permit holder will furnish / upload self-declaration in Annexure-C at the time of making application for renewal of Permit."

The applicant was issued show cause notice as to why the pp shall not cancelled for keeping the vehicle off road more than one year. Accordingly he has filed show cause and it was put up before Chairman, STA for necessary orders. Chairman, STA pleased to pass order to place it in the STA meeting.

As per order No/5221 dtd.05.05.21 taking into account difficulties faced by stage carriage owners for the period from March to December, 2020 (due to situation arising out of COVID-19 in the country and in Odisha), it has been ordered while considering renewal/cancellation of permanent stage carriage permit, period of off-road from March to December, 2020 shall be excluded while computing total off-road period.

In the present case the vehicle No.OR08C-0915, the total off-road period comes to two years excluding the grace period.

The applicant Sri Nilakantha Dash has been noticed vide this office letter No.8169TC dated 05.08.2021 to appear before STA for hearing through video conference.

The matter is placed before STA for decision.

ITEM No.38. Delegation of power in favour of Chairman, STA for grant of All India Tourist Vehicle Permit.

All India Tourist Vehicle (Authorization or Permit) Rules, 2021 has been finally notified by MORTH, Government of India vide GSR No.166(E) dated 10.03.2021 which came into force on 01.04.2021.

Under Rule 2 (1) (c) of said rules, permit and authorization will be issued by State Transport Authority.

Power to grant All India Tourist Permit and Authorization may be delegated in favour of Chairman, STA for disposal of such applications. The matter is placed before STA for decision.
