ORDER

Submission of Medical Certificate in Form 1A is mandatory while making application for issue of learner's license for transport vehicle, addition of another class of vehicle in existing driving license, renewal of driving license where applicant has attained age of 40 years, as required under rule 5 of Central Motor Vehicles Rules, 1989 read with section 8(3) of M.V. Act, 1988. After making application online, the applicant is required to submit original Medical Certificate physically visiting concerned RTO office for verification.

In exercise of powers conferred under sub-section (3) of section 8 of Motor Vehicles Act, 1988, Government of Odisha has issued notification in the extraordinary issue of Odisha Gazette No. 1079 dated 09.08.1990 that registered medical practitioners who possess MBBS degree can issue medical certificate in Form-1A as required under rule 5 of CMV Rules, 1989.

Sub rule (3) of rule 5 of CMV Rules, 1989 provides that a medical certificate shall be valid for a period of six months and shall be accompanied by photograph of the applicant to be submitted electronically on the portal.

Sub rule (4) of rule 5 of CMV Rules, 1989 provides that every medical certificate issued by a registered medical practitioner referred to in sub-section (3) of section 8 of the Act in Form 1A, shall only be issued electronically on the Portal.


It was decided to issue of medical certificate in Form-1A electronically under the 5T policy of the Government of Odisha to improve the ease of getting driving license and to have better user experience and to reduce footfall in RTO offices.

Necessary facility has been provided in SARATHI portal where Doctors can issue Medical Certificate directly which eliminates process of submission of Medical Certificate and verification in manual mode. Training on the new SARATHI software for issuance of Form 1 A by doctors online has already been given to all RTOs on 15.09.2021.

The RTOs are required to create awareness among the Doctors under their jurisdiction to register themselves for user credential of SARATHI portal for uploading of Form 1 A can be done electronically. To create the user credential, Doctors can download the Doctor's registration form by visiting the website www.odishatransport.gov.in. The Doctors may be requested to submit the form dully filled along with the required documents at concerned RTO for user creation. Flow chat is attached which can be shared with Doctors for the purpose.

Presently medical certificate in Form-1A in manual mode and digital mode will continue till further order to stop the manual mode.

This order shall be implemented w.e.f. 10.03.2022.




