At the outset the Chairman, STA welcomed all the members of the STA to the 298th virtual meeting of STA.

Proceeding of 297th virtual meeting of State Transport Authority held on 26.08.2022 circulated among all the members vide this office memo No.13594/TC, dated 01.10.2022 is confirmed as no objections have been received.

Action taken by Chairman, STA, Secretary, STA and Joint Secretary, STA as per delegation of powers by STA for the period from 26.08.2022 to 08.01.2023 are approved.

POLICY DECISION:-

- 1. Application fee for grant, renewal, extension, countersignature and transfer of permit etc in respect of stage carriages, contract carriages and goods carriages was prescribed in the year 1998 by amendment of Rule 48 of OMV Rules. In the meantime 24 years have been passed. State Government provided various improved services to public for which fee required to be revised. It was decided to submit proposal to Government to revise various fees under OMV Rules.
- 2. It is noticed that Tourist Permit/Contract Carriage permit holders are operating their buses as Stage Carriage violating permit conditions. Inspite of issue of e-challans against the offenders, they are operating Contract Carriage/Tourist vehicles as Stage Carriages violating the provisions of statute.

After due deliberation it was decided that, wherever Tourist Permit/Contract Carriage permit holders found plying their vehicles and two e-challan issued U/s 192 (A)

of M.V Act 1988 during preceding one year from the date of issue of second e-challan, whether pending or disposed of on payment of fine, steps will be taken for cancellation of permit U/s 86 of M.V Act 1988. The owner of offending vehicle shall not be issued permit within one year from the date of cancellation of permit. NIC may be requested to develop a software not to process application for any permit online for a period of one year.

(b) "Pursuant to the advertisement published in website and daily odia newspaper "The Sambad" and English Newspaper "The Indian Express" on 12.02.2022 and further published in website as well as in daily odia newspaper "The Samaj" and English Newspaper "The Times of India" on 01.03.2022 and 24.03.2022 inviting applications for grant of permanent stage carriage permit in the interstate route Narsinghpur to Kolkata via.Jamsola and back which is notified vide SI No.04 of notification.

The vacancy arose due to cancellation of permanent permit No.51-R-2017 issued to vehicle OR05AP-6346 in 295th STA meeting.

The following applicants have applied for grant of permanent permit on the above vacancy-

- 1. Smt. Gayatri Panda, owner of vehicle No.OD05BB-5855
- 2. Sri Sapan Kumar Mishra, owner of vehicle No.OD02BV-6161

Applicant **Smt. Gayatri Panda**, owner of vehicle **OD05BB-5855** is absent on call. The applicant has submitted the self-declaration in Annexure-A and B. The applicant has not submitted valid Bank Guarantee/Solvency Certificate.

Applicant **Sri Sapan Kumar Mishra**, owner of vehicle No.**OD02BV-6161** is absent on call. He has submitted Bank Guarantee and self-declaration in Annexure-A and B.

As per Vahan data no VCR/e-challan drawn under section 192-A of M.V. Act, 1988 against above stage carriage owned by the applicant within one year prior to date of consideration of present application.

Hearing closed.

During hearing Sri J. Pal, Advocate for Sri Sidhartha Kumar Sahoo, owner of vehicle No.OR05AP-6346 submitted that Hon'ble High Court in W.P(C) No.5429 of 2022 has directed no final decision with regard to the notification made on 11.02.2022, vide Annexure-5 shall be taken till 08.04.2022.

The matter is deferred to next STA meeting for decision.

In the meantime M.V. Appeal No.03 of 2022 filed by Sidhartha Kumar Sahoo and M.V. Appeal No.04 of 2022 filed by Madan Mohan Sahoo are dismissed by Hon'ble STAT vide judgment dated 22.12.2022.

Heard, Sri M.B.K. Rao, Advocate on behalf of Gajendra Nayak, owner of vehicle OD01AM-3166 through video conference. He stated that he has already filed Certified copy of judgment dated 22.12.2022 by Hon'ble STAT in M.V.A. No.04/2022 (filed by Madan Mohan Sahoo, owner of vehicle OD05AJ-8529) along with a memo on 30.12.2022. That since the order to notify the route Narsinghpur to Kolkata has already been notified on 11.02.2022 and the petitioner along with three others have already applied for grant of permanent permit and participated in the matter which was heard by STA in its 296th STA meeting held on 07.04.2022. Decision of STA was deferred due to pendency of M.V. Appeal No.04/2022, as such the order passed by Hon'ble Tribunal to notify the route stands complied requiring no further notification. The appellant Madan Mohan Sahoo did not avail the opportunity to file application afresh for grant of permit as directed by Hon'ble High Court in W.P. (C) No.5363 of 2022. Hon'ble Tribunal while adjudicating decision of STA to cancel permanent permit of Madan Mohan Sahoo – appellant upheld decision of STA regarding cancellation of permanent permit. Hon'ble Tribunal while dismissing the appeal, has not interfered with the decision taken by STA



in its 295th meeting to notify the route. He submitted that decision pending by STA pursuant to notification dated 11.02.2022 in respect of route Narsinghpur to Kolkata may be taken to its logical end.

Applicant Shri Mahendranath Behera, Owner of vehicle No.OD11R-4661 is represented by Advocate Sri Indrajit Pal Babu. He submitted that application filed by Mahendranath Behera may be considered for grant of permanent permit.

Members of STA have gone through the judgments passed by Hon'ble STAT in M.V. Appeal No.03 of 2022 and No.04 of 2022. In the said judgments following points are decided by Hon'ble Tribunal.

- (i) Upheld decision taken by STA in 295th meeting to cancel permanent permits issued to Madan Mohan Sahoo and Sidhartha Kumar Sahoo appellants and dismissed appeals filed by them.
- (ii) It was directed to proceed with the issuance of fresh permit in the Interstate vacant routes from Narsinghpur to Kolkata via.Jamsola & back by inviting fresh applications from the interested stage carriage owners as per law within a reasonable period.

Learned Advocate appearing for applicant Gajendra Nayak prayed to consider his application for grant of permanent permit pursuant to earlier advertisement and not to advertise the vacant route Narsinghpur to Kolkata by inviting fresh applications.

Such submission made by Advocate Sri Rao is not acceptable to implement one part of the judgment and not to implement second part of the judgment as mentioned above.

Considering submission made by Sri M.B.K. Rao, Advocate and Advocate Sri Indrajit Pal Babu, after due deliberation it was decided to notify the route Narsinghpur to Kolkata inviting fresh applications from the interested stage carriage owners for issuance of fresh permit in accordance with law. It was resolved that decision on the applications filed by bus operators which was placed in the 296th STA meeting will be taken in next STA meeting along with applications that may be received pursuant to fresh advertisement.

ITEM NO.4.2:- PURI TO KOLKATA VIA.LAXMANNATH AND BACK.

The matter was placed in the 296th and 297th STA meeting and decision deferred due to pendency of M.V. Appeal No.05 of 2022 before Hon'ble STAT.

Since the matter is pending before the Hon'ble Tribunal, the matter is deferred to the next STA meeting.

ITEM NO.7.2:-APPROVAL OF PERMANENT PERMIT ON THE ROUTE BARIPADA TO BHUBANESWAR VIA.BALASORE, BHADRAK AND BACK IN RESPECT OF VEHICLE NO.OD01B-1187.

After careful consideration, the Chairman, STA has granted permanent permit in favour of Rajesh Kumar Periwal, owner in respect vehicle No.OD01B-1187 in the route Bhubaneswar to Baripada via.Cuttack, Bhadrak and Balasore and back with vacant slot no.132 in up trip and vacant slot 22 in down trip Cat-A which is approved.

INTER-REGION CASE MATTER

ITEM NO.8.1:- CONSIDERATION OF PERMIT ON THE ROUTE RAJATOTA TO CUTTACK VIA.JARAKA CHANDIKHOLE, BARI IN RESPECT OF VEHICLE NO.OR05AD-0721.
