Sir.

In inviting a reference to the aforesaid subject, it is to inform you that Govt. in Commerce & Transport Department has amended the EV Policy -2021 vide Notification No. 4709/T dtd. 26.04.2023 and also issued Corrigendum Notification No. 4995/T dtd. 03.05.2023. The copies of Notification and letter as mentioned under reference are enclosed herewith.

As per the corrigendum issued by the Government vide Notification under reference, the electric vehicle purchased on or after 26.04.2023 are entitled to avail subsidy as per amended slab and electric vehicle purchased on or after 01.09.2021 but before 26.04.2023 are entitled to avail subsidy as per pre-amended provision.

Further it has also been clarified by Government that the electric vehicle purchased by any Government Departments / offices shall not be entitled for subsidy under Odisha EV Policy-2021.

In the amended provision of Odisha EV Policy it has been prescribed to grant subsidy in respect of 2 Wheeler & 4 Wheeler on the basis of battery capacity. As per the CMVR, the Vahan Software does not capture the battery capacity in vehicle detail and this information is also not available in Homologation Portal developed by NIC. In order to capture the battery capacity, the manufacturer of all 2 wheeler & 4 wheeler electric vehicles are required to upload the battery capacity in Odisha EV Subsidy Portal by registering their EV model. A step by step procedure prepared by NIC is enclosed herewith.

The RTOs are requested to intimate the respective electric vehicle manufacturer through the electric vehicle dealer under their jurisdiction for registration of their electric vehicle model for grant of subsidy to purchaser.

The above instruction should be strictly followed.

Subject- Amendment of Odisha Electric Vehicle Policy, 2021

Whereas Government of Odisha have notified the "Odisha Electric Vehicle Policy, 2021" vide Resolution No.7645/T dt.01.09.2021 published in the Extraordinary Gazette No.1358 dt.02.09.2021 with an aim for adoption of 20% electric vehicles by the end of 2025 as a measure of reduction of vehicular pollution.

However, it is found that about 4.48% of electric vehicles have been registered by the end of 2022 which is not satisfactory in comparison to the policy objective.

Now therefore, Government in pursuance of clause-11.5 of the Odisha Electric Vehicle Policy, 2021 have been pleased to amend clause 4.1.1 of the said Policy, i.e., the purchase incentive which will be effective during Policy period as follows:

1.	Two wheelers	Rs. 5000/- per kwh	Rs. 20,000/-
2.	Three wheelers	-	Rs 30,000/- per vehicle (flat)






