

TENDER CALL NOTICE FOR HIRING OF VEHICLE

Sealed quotations are invited from interest and reputed travel Agencies/Tour Operators or Private Individuals for providing one Light Motor Vehicle like Tiago/Bolt/Celerio (Petrol) etc. which must confirm to the terms and conditions for the use of officials of Road Safety Cell, STA, Odisha Cuttack on monthly hire as per Finance Department Norms.

1. The vehicle must be in Road worthy condition and shall not be more than three years old from the initial registration and must have valid registration certificate, insurance certificate, fitness certificate, valid contract carriage permit, proof of up-to-date tax payment etc.
2. The driver of the vehicle must have a valid driving license to drive Light Motor Passenger Vehicle and should be sufficiently experienced in driving light motor vehicle.
3. The Driver should be well behaved, gentle and polite in nature.
4. Rs.1000/-(Rupees one thousand) only in shape of A/c Payee Bank Draft drawn in favour of Joint Commissioner Transport(Road Safety)-Member Secretary ORSS, Cuttack shall be enclosed with the quotation as EMD which is refundable. EMD of unsuccessful bidders shall be refunded after finalization of the tender process.
5. Rs.5,000/-(Rupees five thousand) only to be deposited by successful bidder as security deposit in shape of Account Payee Bank Draft drawn in favour of Joint Commissioner Transport(Road Safety)-Member Secretary, ORSS, Cuttack. The amount will be refunded after the vehicle disengaged subject to deduction, if any.
6. The monthly hire charges shall be quoted in the Bid information(excluding Fuel and Lubricants)
7. Efficiency of the vehicle per litre shall be indicated.
8. Details of the make and year of manufacture of the vehicle, registration no., mileage (KMs covered per litre) and name of the Driver with Driving License No and period of validity should be provided in the Bid to be furnished.

9. The vehicle owner shall provide the POL during duty period. The quotation shall indicate the monthly hiring charges and the cost of POL separately.
10. The Quotations completed in all respect in Annexure-I & II should reach the undersigned on or before 22.11.2021 by 1.30 P.M and shall be opened on the same day at 4.00 P.M. The bidder, if so desires, may remain present either by person or through their authorized representatives at the time of opening of quotation.
11. Authority reserves the right to cancel any or all the quotation without assigning any reason thereof.
