TERMS AND CONDITIONS

- 01. The intending tenderers are here by advised to obtain the auction vehicle list and tender application form from the STA website as mention in the notice and inspect the seized vehicles kept in different places as mentioned in the auction vehicle list well in advance before submitting the sealed tenders. - 02. The intending tenders will have to submit an earned money of Rs. 5000/- (Five Thousand) only against each of the vehicles in shape of Bank Draft / Bankers cheque in favour of Regional Transport Officer ,Angul payable at SBI Angul along with the sealed tender . Tender papers without EMD in shape of Bank Draft / Bankers cheque will be rejected.
