## **TERMS AND CONDITIONS**

01. The intending tenderers are hereby advised to obtain the auction vehicle list and tender application form from the STA website as mentioned in the notice and inspect the seized vehicles kept in different places as mentioned in the auction vehicle list well in advance before submitting the sealed tenders. Submission of sealed tender will be taken as sufficient proof of the tender to have inspected the vehicles put for sale and no further complaint regarding the condition of the vehicle will be entertained on any circumstances. The auction sales of the seized vehicles are done **as is where is** basis.

02. The intending tenders will have to submit an earnest money of Rs. 5000/- (Five Thousand) only against each of the vehicles in shape of Bank Draft / Bankers cheque in favour of Regional Transport Officer, Angul payable at SBI Angul along with the sealed tender. Tender papers without EMD in shape of Bank Draft / Bankers cheque will be rejected. If a tenderer wants to bid for more than one vehicle, then he has to apply in separate tender form for each vehicle. However, he can deposit the earnest money cumulatively in one Bank Draft / Bankers cheque in favour of the Regional Transport Officer, Angul payable at SBI Angul. In this case, all the tender form with cumulatively in one Bank Draft / Bankers cheque should be submitted in one sealed cover.


In case of successful tender the amount will be adjusted towards sale value. In case of un-successful tender the amount of EMD shall be refunded.

03. All the tenders received will be opened in the presence of the tenderer or their authorized agents if they are present at 04.00 P.M on 19.12.18. In their absence the tender application received from them will be treated as cancelled. If the date of tender is declared as a Govt. holiday the tenders will be opened in the next working day as per the scheduled time. Delay in postal delivery shall not be taken into account. The tender cover should be superscribed as **TENDER FOR VEHICLES.**

04. Tender with highest offer of BID amount shall be accepted and such tenderer shall have to deposit 25% of the accepted highest tender amount including the EMD amount immediately on the spot and rest 75% within 7 days from the date of issue of ratification order or confirmation of the tender. However, the undersigned reserve the right to allow more time to the highest bidder for payment of 75% of the accepted highest tender amount for the interest of the state. The highest tender below the upset price will be referred to the competent authority for decision.



05. In case the highest tenderer fails to deposit the tender amount within the stipulated period from the date ratification order/ confirmation of tender, 25% of the tender amount including EMD amount deposited on the date of opening of the tender will be forfeited to Govt. and the vehicle will be put to resale entirely at the risk of the highest tenderer.
06. The vehicles shall not be delivered to the highest tenderers till full payment is made and other formalities are fulfilled.
07. The highest tenderers shall take delivery and remove the vehicle from the spot within 15 days from the date of ratification order/ confirmation of tender and full payment of the highest tender amount falling which no claim will be entertained on any circumstances latter on and the custody and safety of the vehicle shall be the responsibility of the tenderer. Failure to remove the vehicle within the time bar, ground rate at the rate of 1% of the tendered amount will be charged for each day or part of the day till removal of the vehicle from the site.
08. Since these are seized vehicles and seized for violation of motor vehicle law, no tools, RC books, or other document of the vehicles will be supplied to the highest tenderers.
09. The transfer of ownership of the vehicles will be made on deposit of requisite fee and submission of proper application form and other required documents by the highest bidder.
10. No one except intending tenderers or the authorized representative of the tenderers shall be allowed at the time of opening of seal tender.
11. Tender Application form shall not be accepted after 8.00PM of 07/12/21.
12. In case of any complain/ objection or claim relating to the auction sale is raised, then the decision of the undersigned shall be conclusive.
13. Any dispute/litigation on the auction sale shall be subject to the jurisdiction of Angul district (Angul & Athamallik subdivisions) only. The undersigned reserve the right to accept or reject any or all the tenders without assigning any reason thereof.
