Hon'ble Supreme Court in aforesaid case has directed that the third party insurance cover for new cars should mandatorily be for a period of three years and for two wheelers, it should mandatorily be for a period of five years.

You are therefore, requested to implement direction of Hon'ble Supreme Court in letter and spirit and ensure that at the time of registration of all new cars and two wheelers (both transport and non-transport) same should have third party insurance for three years and five years respectively.
