OFFICE ORDER

After abolition of border checkgates in the State of Odisha, other state vehicles (other than National Permit (goods carriage) / All India Permit (tourist vehicles) / Countersignature Permit holders) entering into Odisha plying temporarily in the State of Odisha are facing problem in making payment of M.V. Tax, Addl. Tax and permit fee due for Odisha and in getting temporary permit. In order to facilitate vehicle owners in respect of vehicles as aforesaid, a web based e-Checkpost portal has been launched by the Government of Odisha. Other State vehicle owners can pay the tax, fee and obtain the temporary permit online before entering in to Odisha by visiting to the e-Checkpost portal (<https://parivahan.gov.in>) from any place to their convenience by availing online facility. After making application online, payment of tax and fee, permit copy will be generated instantly. The vehicle owners can download receipts for payment of tax, fee and permit copy and get printout at their convenience before entering in to Odisha for hassle free movement of vehicles in the State of Odisha. It is clarified that as per Section 66 (3) (i) of M.V. Act, 1988, goods vehicle weight of which does not exceed 3000 kilograms is exempted from the requirement of permit and in such case the vehicle owner will have to pay tax at applicable rate.

The e-Checkpost system has been introduced under the 5T policy of the Government of Odisha to improve the ease of getting the permit and payment of tax, fee for other state vehicles and to have better user experience.

All RTOs are hereby directed not to issue temporary permit / accept tax and fee in respect of any other State vehicles as specified above. Further, if other state vehicle is found to be plying within Odisha without payment of tax and having valid permit, eChallan shall be issued and tax be collected from these vehicles as per law.

Enforcement Officers can cross-check the payment details of the vehicle by logging on to the portal using their credentials from <http://parivahan.gov.in>. They can

also verify the payment and permit validity status by sending SMS to 7738299899 in the following template:

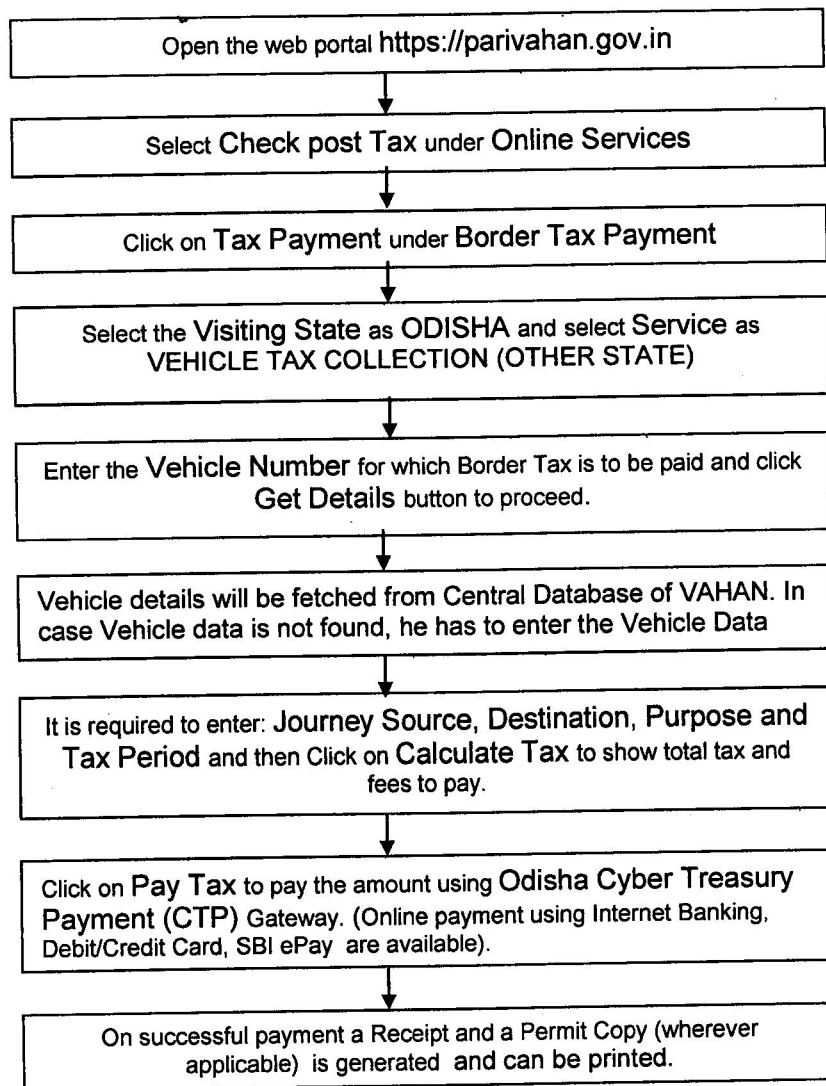

- iv. (b) Rate of tax for West Bengal vehicles having seating Capacity > 25 is Rs. 50 per seat for 7 days. Such vehicles will not be issued permit for more than 7 days at a time.
