That it was decided by STA to rationalise timing of Stage Carriages plying in the route Bhubaneswar / Cuttack - Bari, Jajpur Town , Bandhadiha and notice was published on 18.07.2019 in New Papers. That taking into account the existing permits a draft rationalised timing was prepared and published on 20.11.2019 as at inviting objections and suggestions. Thereafter taking into account all objections and suggestions, final draft rationalisation timing was prepared & published on 22.10.2020. After finial rectification, the vacant slots shall be published in the STA website and interested bus owners may applied for new permits through OPMS.
