ORDER

Government in Commerce and Transport (Transport) Department order No.9445/T dated 01.12.2020 (copy enclosed) has instructed that additional fee for delay in applying for renewal of Driving License and Registration Certificate as per notification No. GSR 1183(E)/ dt.29.12.2016 issued by Government of India, Ministry of Road Transport and Highways (Rule-32 of Central Motor Vehicle Rules, 1989) will not be collected in view of order passed by Hon'ble High Court of Orissa in W.P.(C) No.18124/2019 subject to outcome of the Civil Appeal bearing No. 11216/2017 pending before Hon'ble Supreme Court.

In view of above, to apply for renewal of Driving License and Registration Certificate it is instructed that:

1. Renewal of Driving License (DL)

- Where the application for renewal of Driving License is made either one year prior to or within one year after the date of its expiry, the applicant is not required to appear for driving test.
- After one year of expiry of the Driving License (DL), the applicant has to appear for the driving test.
- Additional fee of rupees fifty for a period of delay of one year or part thereof will be charged separately for each category.
- The revised additional fee payable by DL holder for delay in applying for renewal of Driving License will be entered against the concerned DL and if Govt. of India succeeds in the Civil Appeal as mentioned above, the additional fee will be collected from DL holder as per revised rate.

2. Renewal of Registration Certificate (for non-transport vehicle only)

 After expiry of validity of registration certificate, the registered owner need not require to pay any additional fee for renewal of registration.

- The revised additional fee payable for delay in applying for renewal of Registration Certificate will be entered against the concerned registration records and if Govt. of India succeeds in the Civil Appeal as mentioned above, the differential amount will be collected from the regd. owner as per revised rate.
- Owner of a motor vehicle can file application online for renewal of registration of his motor vehicle before any Registering Authority of Odisha irrespective of his place of residence and business in Odisha if all data of the vehicle are correctly available in VAHAN Portal.
- In case any vehicle owner intends to renew his Registration Certificate (RC) before the RTO other than the original Registering Authority, at the time of making application for Renewal of Registration (RR) online, the applicant will have to apply either for Transfer of Ownership (TO) or Change of Address (CA).
- In case one time tax has not been paid in respect of non-transport vehicle for which renewal of registration certificate applied for, his application will be considered after payment of arrear tax and penalty, if any.
- The procedure for online Renewal of Registration Certificate (RC) is enclosed at Annexure-A.
- 3. Transfer of Ownership (TO) / Change of Address (CA)
- The vehicle owners can file application online for Transfer of Ownership (TO) or Change of Address (CA) before any Registering Authority in Odisha irrespective of his place of residence and place of business anywhere in Odisha.

Go to www.parivahan.gov.in

Click on 'online service'.

Click on 'vehicle related service'.

Click on 'Other state'

Enter vehicle no & click on proceed

Then click on 'Renewal of registration' icon

Enter last 5 digit chassis no & click on 'validate regn_no/chasi_no'

Click on generate OTP & click on submit

Enter OTP & click on submit

Select the TO or CA option to apply for other RTO than the original RTO

In a Disclaimer box, the details like fee collection, current address, permanent address, chassis number in full, engine number in full and colour of the vehicle will appear. Verify the correctness of data.

If the displayed data is not correct, tick in the 2nd checkbox and click on Cancel Button to cancel the application process

Apply to the concerned Registering Authority to modify the vehicle data. The details are available in the website **www.odishatransport.gov.in** After rectification, follow the same procedure again If the displayed data is correct, tick in the 1st checkbox and click on confirm payment.

After payment receipt is generated & owner has to download all the Forms at the time of receipt print

Print the forms & sign in the required places

Upload the documents

Visit RTO office with the printed document which were uploaded along with the vehicle
