## ORDER

As a part of 5T initiative of State Government to improve the user experience, it is decided that all transactions relating to Government revenue and service charges of concessionaire in VAHAN portal for vehicle related services will be made in ONLINE and URL mode only w.e.f. 11.01.2021 and no cash will be accepted at RTO counters for vehicle related services at all RTOs of the State.

The users are already making the payment related to driving license services in SARATHI portal in online mode only w.e.f. 16.03.2020.

Vehicle owners can avail all the vehicle related services like pay the tax, fee, upload document, apply and take printout of Permits, Fitness and tax/fee receipts etc. online by visiting https://parivahan.gov.in . This will help in reducing the long queue in RTO office counters for making payments and will result in improved user satisfaction.
