ORDER

In continuation with order No.9935 dated 16.11.2020 issued by this office regarding issue of Trade Certificate to financier, paragraph (5) shall be substituted with the following.

(5) Henceforth a trade certificate in Form – 17 will be issued to financier in respect of every vehicle as per Rule – 39 of CMV Rules, 1989 and contain the following particulars: (viz ;OD-02-TCF-IFSC Code/CIN Code (last six digits of CIN number allotted to non-banking finance company (NBFC) or eleven digit IFSC code in case of Bank)-2020-NNNNN)

- (a) State Code – OD.
- (b) RTO Code -(viz. 01 or 02 etc.)
- (c) TCF No.- (trade certificate for each class of vehicle, TCF-for financier)
- (d) YEAR-.....(Four digit)
- (e) Trade Certificate SI. No.....(5 digit serial number from 00001 to 99999) for that financier.
- (f) Period of validity:- from ----- to -----

In all other cases where an application for registration of a motor vehicle which is held under a hire-purchase, lease or hypothecation agreement is made and the financing agency / office/institution does not have the IFSC Code/ CIN Code, RTO will issue 3 digit Serial No. in the format viz. OD-02-TCF-NNN-2020-NNNNN.

This order and order No.9935 dated 16.11.2020 are equally applicable to all motor vehicle dealers and manufacturers across the State.

The Trade Certificate to motor vehicle dealers and manufacturers contain the following particulars: (viz ;OD-02-TCD-NNN-2020-NNNNN)

- (a) State Code – OD.

- (b) RTO Code -(viz. 01 or 02 etc.)
- (c) TCD No.-(trade certificate for each class of vehicle, TCD-for dealer)
- (d) YEAR-.....(Four digit)
- (e) Trade Certificate Sl. No.....(5 digit serial number from 00001 to 99999) for that dealer.
- (f) Period of validity:- from ----- to -----

At the time of sale of new vehicle, the dealer shall furnish following particulars in Form-20.
