ORDER


As per the 5Ts Policy of Government of Odisha and with a view to provide hassle free services to stakeholders, the citizen can apply in online mode, for International Driving Permit, upload the required documents (Passport, VISA, medical certificate), pay fee and book slot at their place of convenience by visiting to the portal (<https://parivahan.gov.in>) from any place of their convenience through online facility.

The applicant has to visit Office of the Principal, Govt. Driving Training School, Bhubaneswar on the appointed date and time for verification of original documents of the uploaded documents. The applicant has the option either to carry the physical printed copy of the appointment slip or can show the digital copy in the mobile. After verification of documents, the Principal DTS will print and issue the International Driving Permit (IDP) on the same day.

As per rule-2 of CMV Rules, 1989 "International Driving Permit" license is issued by a licensing authority in India under Chapter II of the M.V.Act, 1988 to an Indian National authorizing the person specified therein to drive any categories of motor vehicles as specified in Form 6-A in the areas or territories of countries other than India but excluding the countries with whom there are no diplomatic relations.

Rule 16(4) of CMV Rules, 1989 provides that every International Driving Permit issued by a licensing authority shall be in Form 6- A and shall be valid for a period of not more than one year from the date of issue, as the case may be, or till the validity of the driving license, whichever is earlier.

The process flow for applying online for International Driving Permit, uploading of documents, payment of fee and booking of slot is annexed.

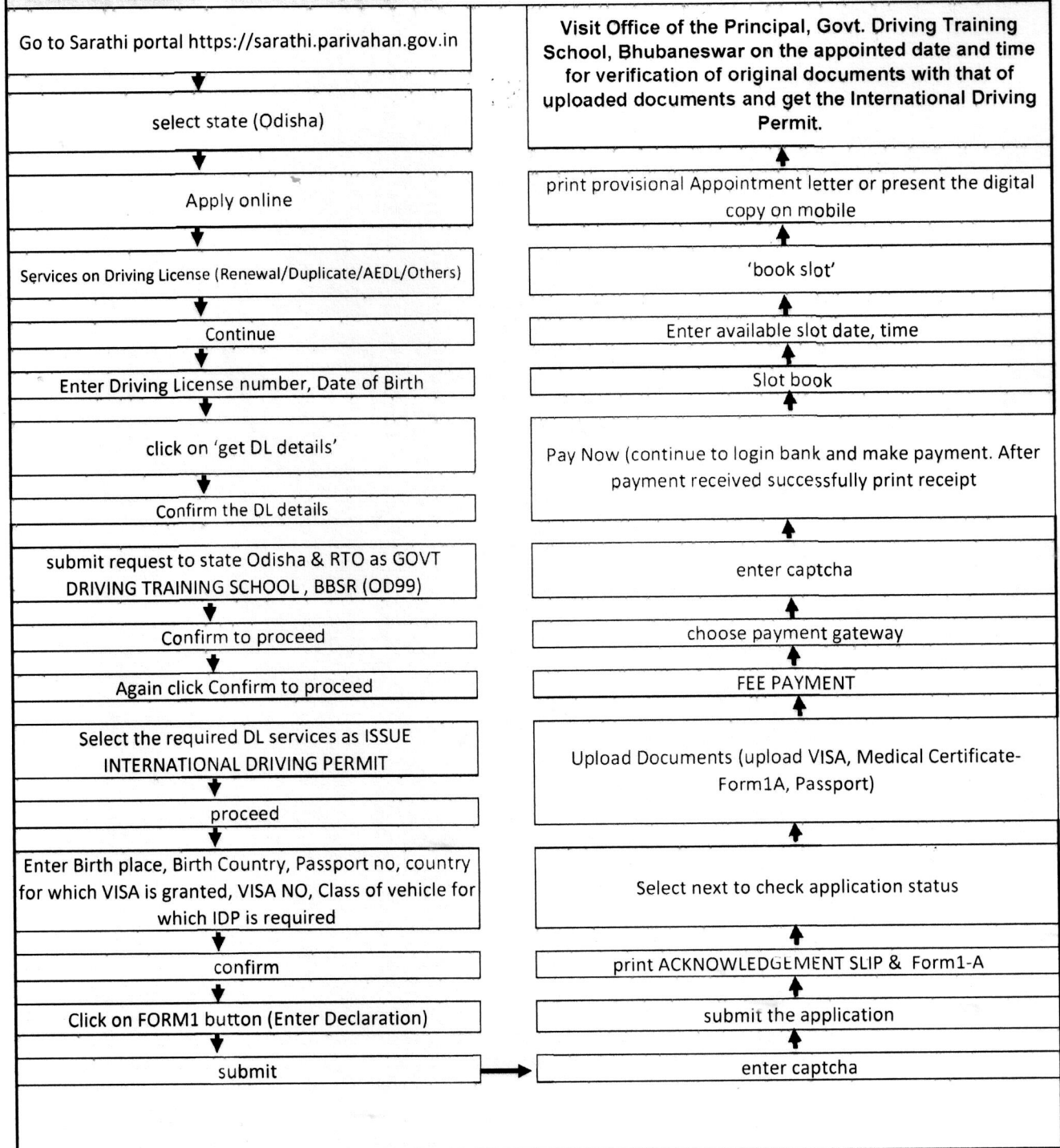
