

**NOTIFICATION**

In exercise of powers conferred by sub-section (2) of section 112 of Motor Vehicles Act, 1988 read with sub-rule (1) (a) of rule 173 of Odisha Motor Vehicles Rules, 1993 fixes the maximum speed in respect of the class of motor vehicles as specified in the table below:-
