

ORDER

Section 56 of M.C. Act, 1988, Rule 62 of CMV Rules, 1989 and Rule 22 of OMV Rules, 1993 prescribes procedure for grant / renewal of Fitness Certificate to transport vehicles.

In order to ensure transparency at the time of grant and renewal of fitness certificate to transport vehicles, an order was issued vide this office order No. 13285/TC dated 08.12.2021 for issuance of Fitness Certificate through M-Vahan Application developed by NIC. The application will keep GPS based location record and images of the vehicles during inspection. The inspection can be carried out only when the vehicle is physically present in the designated geo-fenced area.

To make things better for citizens, the system has been further improved. Now, the vehicle owners can file online application in VAHAN for renewal of Fitness Certificate and produce the vehicle for inspection before any Registering Authority in the state of Odisha as per their convenience irrespective of the place where the vehicle is originally registered. The vehicles registered at RTO, Cuttack will be inspected only at the Automated I&C Centre of RTO, Cuttack.




