Applications are invited from the stage carriage owners for grant of Permanent Permit in the vacant Inter-State and Inter-region routes. List of vacant routes has been published in the official website for information of general public. Interested stage carriage operators may apply in the prescribed form / online through OPTICS during the office hours on or before 16.03.2023 at 05.30P.M.

Application form (Annexure-D) and self declaration in Annexure-A and Annexure-B can also be downloaded from the website <a href="http://odishatransport.gov.in">http://odishatransport.gov.in</a> annexed to 293<sup>rd</sup> STA meeting held on dt.14.12.2020.

Application in prescribed form duly filled in and signed by the registered owner of stage carriage accompanied with money receipt showing deposit of Rs.500/- towards application fees, self-attested copy of R.C, valid Fitness Certificate, Insurance Certificate, tax payment particulars and Solvency Certificate issued by Competent Authority or Bank Guarantee in original from any nationalized Bank valid for one year for Rs.99,000/- pledged in favor of Secretary, STA, Odisha, Cuttack along with self-declaration in Annexure-A and Annexure-B shall be submitted in this office within the date and time mentioned above.

Bus owner holding Permanent / Temporary Permit in any route shall not be eligible to apply. Any application made without surrendering existing Permanent / Temporary Permit shall be summarily rejected. Year of manufacture, make of bus, type of bus and facilities provided in bus (Non-Deluxe, A/C Deluxe, A/C Deluxe Sleeper etc.) and the vehicle in question is not offroad at the time of making application are to be specified in the application. Incomplete application and application received beyond the specified date shall not be entertained. Applicant submitting wrong information and suppression of information, his / her application shall be summarily rejected.

The Bus owners applying for permanent permit in the vacant interstate routes of West Bengal will furnish BS-IV model vehicle or a higher one for consideration of permit. Similarly, the bus owners applying for permanent permit in the vacant Interstate routes of Chhatisgarh will furnish a vehicle not more than ten years from the date of manufacture for consideration of permit.

All applications received within the cut-off date for grant of Permanent Stage Carriage Permits on Inter-State vacant routes will be considered together by STA.
