Year of manufacture, make of bus, type of bus and facilities provided in bus (Non-Deluxe, A/C Deluxe, A/C Deluxe Sleeper etc.) and the vehicle on question is not off road at the time of making application are to be specified in the application. Incomplete application and application received beyond the specified date shall not be entertained. Applicant submitting wrong information and suppression of information, his/her application shall be summarily rejected.

All applications received within cut-off date for grant of Temporary Stage Carriage Permits on different vacant routes will be considered together by Chairman RTA, Puri.
