126. Route:- BHUBANESWAR (BARAMUNDA) TO BRAHMANAPADA VIA DASHAPALLA, MADHAPUR, SANKARAKHOLE, TIKABALI AND BACK, SK ALIM BUX, OWNER OF VEHICLE NO. OR05AK5775.

The applicant is absent. There is no objection.

The vehicle is 2010 model. and is proposing to ply in ghat road. The application is not considered in view of the safety of traveling public.

3. Adv. S. Jena on behalf of Smt. Minakshi Dash owner of the vehicle No. OR01T-3214 filed objection stating that there is clash of time at Udala.

It will be decided jointly along with other applications applied in the same slot.

256. Route:- SAGJORE TO JORDA VIA BIRKERA, BIRIDA AND BACK, SAIRINDHRI PATEL, OWNER OF VEHICLE NO. OD14AA1057.

Adv. S. K. Mishra is present for the applicant.

The application is rejected as withdrawn.

257. Route:- BHUBANESWAR (BARAMUNDA) TO JOKA VIA KUAKHIA, PANIKOILI AND BACK, RANJAN KUMAR MAHALA, OWNER OF VEHICLE NO. OD11AA4292.

Adv. H. P. Mohanty is present for the applicant.

1. Adv. S. Mishra on behalf of the Sri Deepak Karmakar owner of the vehicle No. OD11J-0999 and Sri Tushar Mohapatra owner of the vehicle No. OD11P-3399 raised the objection that the vehicle of the applicant purchased a new chassis on 07.06.2023, registered on 21.06.2023, which is not possible to complete the body work within a month. As such, it is apprehended that, the vehicle is now undergoing body building work at HNS Body builders, Rajasthan. The applicant therefore requested to enquire into the matter. He also said that there is clash of timing from Rairangpur to Bhubaneswar.

It will be enquired by zonal Dy. Commissioner Transport to ascertain the factual position.

2. Sri Jyotirmay Behera owner of the vehicle No. OR11K-2338 filed objection stating that there is clash of time from Bhubaneswar to Joka.

3. Sri Tushar Mohapatra owner of the vehicle No. OD11AA-4292 filed objection which was raised by Sri S. Mishra, Advocate regarding registration of the vehicle of the applicant within a short period of purchase of chassis. He therefore objected that this vehicle is now in Garage for body building work, which may be enquired into.

The vehicle is non existence as the body is being built at Jeypore, Rajasthan, matter is under enquiry, application is rejected. Action

should be initiated against the erring official who has allowed registration of the vehicle without physical verification of the bus.

1. Adv. MBK. Rao on behalf of Sri ManasRanjan Mishra, owner of the vehicle No. OR19N-1600 filed objection stating that departure timing of the objector's service at Talcher is 11.00, whereas the dep. Timing of applicant's service is 10.45 hrs, which is 15 minutes ahead of Objector's service, resulting in clash of timing at Talcher.

2. Adv. S. Mishra on behalf of Srimati Nayak, owner of the vehicle No. OD25D-4515 filed objection stating that there is clash of timing at Nayagarh (Up trip).

The applied route covers part of rationalized route, hence application is rejected.

259. Route:- MAHULPAL TO KAMAKHYANAGAR VIA SUKINDA, BHUBAN AND BACK, TULASI NAYAK, OWNER OF VEHICLE NO. OD02B1533.

Adv. S. Mishra is present for the applicant.

There is no objection. The applied route covers only Jajpur Road area with 6 kms towards Mahulpal in Dhenkanal district. The application is made to avoid intra region permit as Mahulpal is not an important Block, Tahasil or a tourist location. Application is not considered, he is advised to apply before concerned RTA.

260. Route:- BHUBANESWAR (BARAMUNDA) TO OLAVAR VIA BARUAN, JAJPUR TOWN AND BACK, SANDEEP DWIVEDI, OWNER OF VEHICLE NO. OD05BP0939.

Adv. S. Das is present for the applicant.

The applicant has applied in Uptrip slot-39 and in Down trip slot-131.

It will be jointly decided along with other applications applied in the same slot.
