Adv. Sri S.Mishra is present for the applicant.

The proposed route covers portion from Bhubaneswar-Panikoili-Jajpur Road and Bhubaneswar-Balasore rationalized route. Hence the application is considered if it complies 302<sup>nd</sup> STA resolution otherwise rejected.

288.Route- MEREI TO KAUDOLA VIA RAIGHAR AND BACK,SUMAN DASH, OWNER OF VEHICLE NO.OD10W9716

Adv. Sri A.K.Behera is present for the applicant.

Adv. Sri MBK. Rao on behalf of N.Sankar Rao, owner of the vehicle No.OD10U9802 filed an objection stating that there is clash of time atBoriguma.

Sunil Kumar Padhi, owner of the vehicle Nos.OD10N1114 and OD10P1114 filed objections stating that there is clash of timing at Raighar.

One Naka Puspa, owner of the vehicle No.OD24G3517 filed an objection stated that there is clash of time at Umerkote, Nabarangpur.

The route chart appears to be defective in so far as the up and down trip stoppages are not similar. Hence the application is rejected.

Adv. Sri Santanu Das raised the same objections as per SI. No.260 &207 that slot-38 is sub-judice in the Hon'ble High Court of Orissa. Hence requests to allow the change of slot applied by him and consider this new T.P. application. After taking into account new T.P. application in any other vacant slot if possible.

The matter shall be jointly decided alongwith other application with due consideration of Sri Das.



290.Route- POLASARA TO BERHAMPUR VIA PURUSHOTTAMPUR AND BACK, SIBA PRASAD PATRA, OWNER OF VEHICLE NO. OD152899

The applicant is absent.

Adv. H.P. Mohanty on behalf of Hrushikesh Mohanty, owner of the vehicle No. OR07Q8373 stated that the owner of the vehicle No. OR07J1046 operating the service from Polasara to Berhampur surrendered the PP granted by RTO, Ganjam on 11.10.2023. Then Sri Mohanty applied to RTO, Ganjam for the vacant route. The applicant also applied in the vacant route before RTO, Ganjam. But when both the applications of the objector and applicant pending at RTO, Ganjam, the owner of OR07J1046 who surrendered the PP to Ganjam, RTO, surreptitiously applied to STA by inducting another vehicle.

Report may be called for from the DC(SZ) and RTO, Ganjam regarding the veracity of the application on inter/intra region route. After getting the report the application shall be taken up for consideration

291.Route: RANJADA TO LOARAM, RANJAN KUMAR PALEI, OWNER OF THE VEHICLE NO. OR14T7174.

This route and timing has been notified. The vehicle is of 2009 model, hence the application is rejected.

292.Route KOTLINGI TO BERHAMPUR & BACK, SITUN PANDA, OWNER OF THE VEHICLE NO. OD02BT4796
