The Transport Commissioner, Odisha invites competitive bid proposals from interested OEM/ Authorised Distributors / Dealers and Supplier to supply 100 Smart Mobile Phone (Handset) as per detail specification at Annexure-I.

#### **OBJECTIVES**

Office of the Transport Commissioner, Odisha proposes to procure 100 Smart Mobile Phone (Handset) for use by the officials of the Transport Commissioner and its subordinate offices.

#### **SECTION-III: GENERAL TERMS & CONDITIONS**

#### Eligibility Criteria

The bidder should be a registered firm operating for last three years from the date of floating of tender. The firm should be registered under GST. GST Certificate to be submitted along with the tender document.

The firm should have a local establishment / office with service centre in Bhubaneswar or Cuttack.

In case of authorized partners/supplier, the bidder has to submit valid authorization certificate(s) from the Original Equipment Manufacturer (OEM).

Necessary supporting documents on fulfilment of eligibility criteria should be attached for authentication along with a signed copy of the tender document to indicate acceptance of all terms and conditions set forth in the tender. Bidders failing to provide complete information on any of the requirements, their bidsshall be summarily rejected.

#### Cost of Tender Document

Cost of Tender document will be Rs.1000/- (one thousand only) plus applicable taxes.

#### Time of completion of Project:

Supply of the material shall be completed within seven woking days from the date of issue of Purchase Order.

#### Payment term

80% payment will be made after supply of the material as per given timeline to the Transport Commissioner, Odisha.

Balance 20% will be released after 30 days of supply subject to testing and certification of functioning of the material.

#### Bid Validity Period

The bid must be valid for **180 days**. Bids containing validity period less than 180 days shall be rejected.

#### Warranty and Support

1 year OEM Warranty + 2 years Extended Warranty

#### Rejection

Before acceptance of the CUG mobile phones with sims, if the phones supplied by the successful bidder is found defective in materials or workmanship or not as per desired specification or otherwise and not in conformity with the requirements of the authority, the Transport Commissioner shall cancel the work order and contract agreement unless successful bidder replace the defective equipment within three working days during warranty/extended warranty period. In this regard the decision of the Transport Commissioner, Odisha shall be final and binding upon successful bidder.

#### Force Majeure

If the execution of the contract/supply order is delayed beyond the period stipulated in the supply order as result of outbreak of hostilities, declaration of an embargo or blockade of fire, flood, acts of God, then Office of the Transport Commissioner, Odisha may allow such additional time by extending the project execution timeframe as considered to be justified by the circumstances of the case and its decision will be final. If additional time is granted by the Office of the Transport Commissioner, Odisha, the supply order shall be read and understood as if it had contained from its inception the execution date as extended.

#### Standards

The materials/equipment's/software shall confirm to the National / International standard, as applicable.

#### Insurance of Equipment

The materials to be supplied should be **insured** by the successful bidder on behalf of the authority from his warehouse to the installation site. The insurance coverage should cover the transport of materials to the destination and till handing over the same to the authority. The materials/equipment found lost or damaged in transit or during supply should be immediately replaced to avoid delay in delivery.

#### Replacement

In case of and kind of damage caused to mobile handset, the bidder must replace the mobile handset or get it repaired or replace by new set within three days.

#### Purchaser's Procurement Rights

Without incurring any liability, whatsoever to the selected bidder, the Purchaser reserves the right to:

Amend, modify, or cancel this tender and to reject any or all proposals without assigning any reason. Change any of the scheduled dates stated in this tender. Reject proposals that fail to meet the tender requirements. Request bidders to clarify on their proposal.

#### Inspections

The mobile phones shall be inspected by the authority before delivery.

#### Other Instructions

Transport Commissioner, Odisha reserves right to cancel the contract in the event of one or more of the following situations:

- Delay in delivery and installation beyond the specified period mentioned in the contract.
- ii) Major discrepancy in hardware & other components noticed during any stage of the project.
- iii) Any other reason as may be specified by the authority which shall be binding upon successful bidder.

Transport Commissioner, Odisha reserves right to ask for any technical clarification and to make technical presentation before technical committee failing which bid may be cancelled.

Un-signed & un-stamped bid shall not be accepted.

Upon verification, evaluation / assessment, if in case any information furnished by the bidder is found to be false/incorrect, the bid shall be summarily rejected and no correspondence, shall be entertained.

No deviations of tender terms and conditions will be accepted. Any violation thereof will lead to rejection of the bid.

Transport Commissioner, Odisha will not be responsible for any misinterpretation or wrong assumption by the bidder.

Transport Commissioner, Odisha reserves the right to alter /increase / decrease the quantity of items, as the case may be, to meet the requirements at any point of time.
