OFFICE ORDER

In the Final Rationalized Timing (Version 10.1) on the route Bhubaneswar/Cuttack-Akhuapada-Bhadrak-Soro-Balasore-Baripada route published in the Website on Dated 06.09.2022 anomaly occurred in it which is corrected as under.

- 1. The vehicle no OD22M9311 operating on the route Bodak to Balasore Via Bhadrak & Back and Bhadrak To Aradi & Back appearing at slot no 30 in up trip is deleted and up trip slot no 30 is Cat-D vacant slot. The vehicle No OD22M9311 will ply in up trip slot no 39 (Cat-C&D) with Bhadrak Dep 08:58 towards Balasore (Arr 10:27).
- 2. The vehicle no ODO1V2111/ OD11L2615 operating on the route Balasore to Rourkela via. Keonjhar & Back appearing at slot no 141 in up trip is deleted. The vehicles ODO1V2111/ OD11L2615 will ply in up trip slot no 142 with Balasore Dep 17:23 & arrives at Baripada 18:57.
- 3. The Bhadrak departure time of vehicles OR05AK7197, OD221037 & OD22Q5387 in up trip slot no 123,133 & 135 respectively are deleted.
- 4. The vehicle no OD22R7383 operating on the Route Chandabali To Bhubaneswar Via Bhadrak appearing at slot no 114 in down trip is deleted & restored to down trip slot no 122. Down trip slot no 114 is declared as Cat-C vacant slot as earlier.
- 5. As per version 10.0 rationalization timing, the vehicle OD01Z8139 is restored to it's slot no.15 (Cat-B Balasore Dep 04:56) in down trip and consequently the vehicles OD22K5454 & OD22B6177 are restored to their down trip Category-C slot no.11 (Bhadrak 6:09-6:13) & slot no 12 (Bhadrak 6:13-6:17) respectively.
- Two vacant slots Category-D&E (Baripada Dep 4:57 Balasore 6:31-6:34 Bhadrak Arr 8:02)
 Category-E (Baripada Dep 5:09 Balasore 6:43) are created in slot no 45 & 49 respectively in down trip.

7. The vehicle no OD11C3639 plying in the route Gopalpur to Bhubaneswar via Bhadrak, Panikoili & Back is deleted from slot no 75 in down trip & restored to Cat- C slot no 80. Down trip slot no 75 is declared as Cat-C (VACANT) & E (VACANT) slot.
