
TENDER CALL NOTICE FOR HIRE VEHICLE

Sealed quotations are invited from interest and reputed travel Agencies/Tour Operators or Private Individuals for providing four vehicles out of which two vehicles will be under category of Zest/Tigor/Swift Dzire/Xcent/Etios (Petrol) or any similar model and segment having the same mileage i.e. 17 kms per litre and hiring charges per month of Rs.26000/-.

ii) Remaining two vehicles will be under category of Ciaz/Honda City(Petrol) or any similar model and segment having the same mileage i.e. 12 kms per litre and hiring charges per month of Rs.30,000/-.


All the above vehicles will be used by the officers of Transport Commissioner, Odisha subject to stipulations made by Finance Department.

1. The vehicle must be in Road worthy condition and shall not be more than three months from the date of initial registration and must have valid registration certificate, insurance certificate, fitness certificate, valid contract carriage permit, proof of up-to-date tax payment etc. Bidder intended to provide new vehicle, he will have to submit booking slip, dealer's confirmation & to submit undertaking to provide new vehicle duly registered within 15 days from the dated of issue of work order.
2. The driver of the vehicle must have a valid driving license of respective class to drive light motor vehicle and should be sufficiency experienced in driving light motor vehicle.
3. The Driver should be well behaved, gentle and polite in nature.
4. EMD Rs.1000/-(Rupees one thousand) only per vehicle in shape of Bank Draft drawn in favour of Addl. Commissioner Transport (Admn.),STA, Cuttack shall be submitted along with the quotation which is refundable after finalisation of the tender process.



5. Security Deposit of Rs.20,000/- (Rupees twenty thousand) only per vehicle shall be made by the successful bidder in shape Bank Draft drawn in favour of Addl. Commissioner Transport (Admn), STA, Cuttack from any rationalised Bank. The amount will be refunded after the vehicle disengaged.
6. The monthly hire charges shall be quoted in the General Bid information (excluding Fuel and Lubricants).
7. Milage per km of the vehicle per litre to be offered shall be indicated.
8. Details of the make and year of manufacture of the vehicle, registration no., mileage (KMs covered per litre) should be specifically provided in the General Bid information to be furnished with the quotation / bid.
9. The vehicle owner shall have to supply POL during entire period of contract. The bid shall indicate the monthly hiring charges and the cost of POL separately as per circular issued by the Finance Department.
10. The bids completed in all respect should be reached in the office of Transport Commissioner, Odisha on or before 07.03.2024 by 1.30 P.M. The bids so received shall be opened on the same day at 4.00 P.M. in the presence of the bidders or their authorized representatives.
