**NOTIFICATION**

In pursuance of the directions of Supreme Court Committee on Road Safety on 23.12.2014, 24.11.2016 and 28.03.2018 and the order dated 30.11.2017 of the Hon'ble Supreme Court in W.P(C) No.295 of 2012, the State Government do hereby reconstitute the "Lead Agency" with Members/Officers from the following Departments/Offices to act as Secretariat of the State Road Safety Council and to coordinate all activities relating to road safety in the State. However, the said Agency can co-opt any other member from other Departments/Agencies.

The Chairman, Lead Agency may depute any other Officer as Sub-Convenor to the Member-Convenor of the Agency.

## **2. Functions of the Lead Agency**

- (i) To work as a Secretariat for the State Road Safety Council, arrange meetings of the Council issue it's Minutes and monitor the implementation of the decisions of the Council by the concerned Departments of the State.
- (ii) To coordinate with the concerned Departments of the State Government to ensure implementation of the directions issued from time to time by the Supreme Court Committee on Road Safety and furnish Compliance Report in a time bound manner.
- (iii) To ensure implementation of the directions given by the Central Government from time to time.
- (iv) To notify annual targets for reduction of accidents and fatalities as fixed by the State and draw up an Annual Action Plan to achieve the targets and monitor its implementation.
- (v) To collate on a regular basis data on road accidents and analyse the data to identify areas/road stretches and categories of accident victims who should be focused upon.
- (vi) To manage the Road Safety Fund and ensure that the Fund is effective.

- (vii) To coordinate all activities such as licensing issues including issues of Driving Licenses, Registration of Vehicles, Road Safety and Features of Vehicles alongwith other allied matters including emission norms.
- (viii) Any other matter relating to Road Safety to be assigned from time to time.


