In exercise of the powers conferred by sub-section (2) and sub-section(4) of section 215 of Motor Vehicles Act, 1988 (59 of 1988) and in supersession of Commerce & Transport (Transport) Department Notification No.7321-LC-TR-40/2014/T dated 18.11.2015 published in the Odisha Gazette extraordinary issue No.1594 dated 20.11.2015, the State Government do hereby reconstitute the State Road Safety Council for the State consisting of the Chairman, Vice-Chairman and other members as indicated at Para-1 and the Council so reconstituted shall discharge such functions as indicated at Para-3 below.

2. The Chairman may co-opt. members from the Press and representatives from the Motor Transport Workers' Union.

3. The Council shall—

(i) advise on all matters pertaining to planning and coordination of policies, practices, standards of safety in the road transport sector;

(ii) formulate and recommend road safety programmes for implementation by State Road Safety Organizations as also other State Agencies in charge of road transportation;


(iii) suggest areas for research and development to improve safety aspects in the road transport sector, including maintenance of statistics of road accidents and their analysis; and

(iv) generally oversee and monitor the road safety measures undertaken in the State.

4. The Council will hold its meeting at least twice a year.

5. The Council shall decide the procedure and methodology to be adopted for its functioning.




