- 2. The Chairman may co-opt. members from the Press and representatives from the Motor Transport Workers' Union.
- 3. The Council shall—
 - (i) advise on all matters pertaining to planning and coordination of policies, practices, standards of safety in the road transport sector;
 - (ii) formulate and recommend road safety programmes for implementation by State Road Safety Organizations as also other State Agencies in charge of road transportation;
 - (iii) suggest areas for research and development to improve safety aspects in the road transport sector, including maintenance of statistics of road accidents and their analysis; and
 - (iv) generally oversee and monitor the road safety measures undertaken in the State.
- 4. The Council will hold its meeting at least twice a year.
- The Council shall decide the procedure and methodology to be adopted for its functioning.
